Introduction

In 2021 we began a revision of our standards framework with the aim to harmonize our standards under one unified system and to take the opportunity to align with our organizational Climate+ strategy. You can read more about endeavors for the unified standard here.

In this file you are presented with the first draft of the unified standard criteria that we have released for public consultation. Below you will find information on how to navigate the standard as well as more background information. 
How to navigate the draft standard

The following table provides an overview of the fibers and materials in the scope of the first draft of the unified standard. The unified standard covers criteria for Tier 4 raw material extraction (e.g., cultivation and extraction of raw materials from the earth, plants or animals) and Tier 3.5 first processing (e.g., ginning, retting, degumming, cottonizing, wool scouring, dissolving pulp, chemical / mechanical fiber recycling). The rest of the supply chain (Tiers 1-3) is not part of the unified standard scope.



In addition to the traditional PDF format of our standards, for the first time, we are releasing a draft standard in a more interactive excel / spreadsheet file with the intent to allow you to customize your view and to only see and comment on sections or criteria of the standard as they relate to your interest or specialty.

In the excel file version, navigate to the tab that says "unified standard." Interact with the file by using the filter drop-down function at any column. For instance, when you click on the material column drop-down arrow, you can use the search function by typing the name of the material you are interested in the search box (see red arrow) such as shown here for "Alpaca." The file will then show the criteria that are tagged to "Alpaca" in the "Material" column.



Alternatively, you can filter by a specific material, as shown below for the example of "Alpaca." Please note, that you will have to drag the window to a larger size to ensure that you have selected all line items that list the desired material. Filtering this way is a little more prone to error than using the search field but is an alternative option to focus on the material of interest.



The search function within the filter box can be used for any column if you want to look for key words of your interest.

*Please note that if you are interested in criteria applicable to recycled MMCF, you need to select both "Recycled" and "MMCF."

Another way to interact with the file is to read it from the top to the bottom.

We thank you in advance for the time you dedicate to this review to help us create a strong unified standard system. We aim to get as much feedback as possible from our stakeholders like you around the globe, so please share the public consultation far and wide.

About this version

This first draft version of the unified standard contains five thematic sections for cross-cutting criteria:

- Organizational Management
- Human Rights and Livelihoods
- Land Use
- Animal Welfare, and
- Facility / Environmental

The second draft will include refined criteria from the first draft following a review of the feedback received during the first public consultation as well as new sections for Tier 4 related chain of custody, trademark use, group certification models and slaughterhouses when material is collected at these sites. Additional normative documents that support the standard will be part of the second draft as well.

Scope of the unified standard

The proposed materials within scope pending the final first version of the standard, following two draft consultations, are fiber crops (cotton), animal fibers (sheep wool, alpaca, mohair, and yak hair) and recycled (synthetics, natural/animal fibers, MMCF).

We are also reviewing opportunities to include cashmere, virgin man-made cellulosic fibers (MMCFs), latex/rubber, and biosynthetics. It is worth noting that we intend to create a system that allows additional new materials to be added over time as the standard system evolves.

In addition, we are researching ways to recognize input materials already certified under different certification systems to avoid auditing fatigue from the producers' side. This means some of the materials proposed for the scope may be added through recognition of external standards rather than through direct Textile Exchange raw material certification.

The criteria in this first draft for public consultation cover the majority of the aforementioned areas. An updated second draft, including the final proposed scope, will be released later this year for a second public consultation.

When the desired goal is to make claims on final certified materials, the rest of the supply chain (Tiers 1-3) will need to be certified against Textile Exchange's Content Claim Standard (CCS) representing chain of custody requirements for the tracking and handling of certified materials. The CCS is not scheduled for revision concurrently with the unified standard this year, but it will be the applicable chain of custody standard that supports the implementation of the unified standard system when this becomes effective after 2024. This means Textile Exchange will review the CCS for any necessary updates following the finalization of the unified standard.
